SALARY AWARDS & SCIENTIFIC AWARDS

TRAINEES

Marie Westby (supervisors: Linda Li and Allyson Jones) was awarded the 2014 Association of Rheumatology Health Professionals Distinguished Clinician Award. The award honors Association members who have demonstrated expert clinical management of persons with rheumatic diseases.

Cam Clayton (supervisor: Linda Li) received funding from The BC Division of The Arthritis Society to pursue a Master's thesis on the topic of using an online monitoring tool to improve physical activity in people with osteoarthritis.

Sharan Rai (supervisors: Hyon Choi and Antonio Aviña) has been awarded a Lupus Canada Scholarship award to pursue her Master's degree.

Arun Agha, **Jimmy Guo** and **Erin Carruthers** have been accepted by UBC Medical School starting this fall.

FACULTY

UBC has appointed **Jacek Kopec** to be the Head of the newly created Division of Epidemiology, Biostatistics, and Public Health at UBC's School of Population and Public Health.

Charlie Goldsmith, the Milan Ilich/Merck Chair in Biostatistics, was in the top 1% of cited authors for Social Science in Medicine in 2014.

GRANTS

Five of the 11 Canadian Initiative for Outcomes in Rheumatology Care (CIORA) research grants given out by the Canadian Rheumatology Association have been awarded to ARC scientists and an ARC scientist is a key participant in a sixth award.

Charlie Goldsmith, the Maureen and Milan Ilich/Merck Chair in Arthritis Biostatistics at ARC, was a key co-investigator on a funded Canadian Rheumatology Association grant entitled "Improving patient outcomes in rheumatoid arthritis may require a deeper understanding of medication adherence". This grant shows the impact of having the only statistical chair in arthritis at ARC and how it can improve arthritis research nationally.

Glen Hazlewood (Principal Investigator) and Cheryl Barnabe, Deborah Marshall, Linda Li, Nick Bansback, Vivian Bykerk and Peter Tugwell were awarded a Canadian Rheumatology Association grant entitled "Development and usability testing of a personalized risk communication tool to facilitate the shared decision of methotrexate treatment options in early rheumatoid arthritis". Since methotrexate is the most commonly used treatment for rheumatoid arthritis and the key drug in rapidly controlling the disease early on, this tool will help patients and rheumatologists decide between methotrexate by pills, subcutaneous methotrexate (i.e., by shot), and methotrexate combined with another drug.

Paul Fortin and Jean Légaré (Chair, Laval University APAB) are co-investigators along with Louis Bessette, Anne-Laure Chetaille, and Holly Witteman on a grant entitled "Measuring the impact of an innovative educational intervention in inflammatory arthritis: a natural evolution of the CHU de Québec's multidisciplinary information session". The Principal Investigator on this grant is Dr. Laëtitia Michou from Laval University. The project will develop an educational program for Eastern-Quebec patients with rheumatoid arthritis, consisting of a DVD with 12 short chapters, presented by a team including health professionals and patients, followed by an in-person session or a teleconference to facilitate key messages understanding. The goal is to make it easier for French speaking patients to find information on inflammatory arthritis.

Mary De Vera received two grants as Principal Investigator. The first was entitled "Collaborative care involving eHealth to improve treatment adherence and health outcomes of patients with gout" and has as co-investigators Carlo Marra, Kam Shojania, Hyon Choi, Antonio Aviña, Alison Kydd, and Melissa Baker. This project will use a novel e-health approach with physicians and pharmacists to investigate the epidemic of non-adherence in patients with gout.

Mary de Vera's second grant is entitled "Inflammatory arthritis patients' perspectives, priorities, and opinions on INterventions FOR MEDication adherence (INFORMED)". The co-investigators are Carlo Marra, Antonio Aviña, Anne Townsend and Sharan Rai. This project will use arthritis patient focus groups to gather information aimed at increasing adherence to arthritis treatments.

Diane Lacaille is the Principal Investigator on a grant entitled "Case managers to improve the management of inflammatory arthritis and associated comorbidities with First Nations communities: A proof of concept study". Her co-investigators are **Cheryl Barnabe, Linda Li, Charlie Goldsmith**, Helen Brown, and Lindsay Crowshoe. This project will use a nurse case manager residing in the community to see whether this helps overcome barriers to care, improves health behaviours and is seen as a positive addition by the communities of Old Massett Village, Haida Gwaii, BC, and Siksika, AB.

Linda Li has received a Canadian Institutes of Health Research grant for her application "<u>Supporting Physical activity & Reducing sedentary behaviour in Arthritis (SuPRA)</u>". Coinvestigators on this grant include: Greg Noonan (MPAP), Diane Gromala (SFU), Chris Shaw (SFU), Paul Adam (MPAP), Richard Smith (Centre for Digital Media), **Alison Hoens, Antonio Aviña, Catherine Backman, Lynne Feehan, Charlie Goldsmith** and **Anne Townsend**. Consumer collaborators include **Ruta Cummings**, **Lianne Gulka** and **Cheryl Koehn**.

Linda Li also received two grants from The Arthritis Society (TAS), the first is entitled "Effectiveness of Online Physical Activity Monitoring in Inflammatory Arthritis (OPAM-IA): A new model of care". Co-Investigators on this grant include **Antonio Aviña, Catherine Backman, Lynne Feehan, Charlie Goldsmith**, **Anne Townsend**, Chris Shaw and Diane Gromala.

The second TAS award is for "Effectiveness of physical activity coaching using Fitbit in people with knee osteoarthritis: A pilot study".

Linda Li's fourth grant is from the Vancouver Coastal Health Research Institute to initiate a project "*Monitor OA*". Co-investigators on this grant are Greg Noonan, **Alison Hoens, Charlie Goldsmith**, and **Lynne Feehan**.

Salary Awards

The Canadian Institutes of Health Research awarded three ARC scientists the prestigious New Investigator Award. **Cheryl Barnabe** (ARC Calgary) won for her application entitled "Arthritis care for Indigenous populations". **Nick Bansback** of (Milan Ilich ARC) successful application is entitled "Can patient-centred care improve outcomes and save costs?", and **Michael Hunt's** (Milan Ilich ARC) award is for his application "Non-invasive treatments to improve disease symptoms and cartilage health for knee osteoarthritis".

Two ARC scientists were awarded the Career Investigator Award by the Michael Smith Foundation for Health Research. **Mary De Vera** (Milan Ilich ARC) won for her application "Pharmacoepidemiologic and pharmaceutical outcomes research to improve medication use, adherence, and outcomes in patients with arthritis". **Antonio Aviña-Zubieta's** award is entitled "<u>Reducing the burden and Gaps IN</u> care for patients with <u>Systemic Autoimmune Pheumatic Diseases (ReGalN SARDs)</u>". In addition, **Dr. Aviña-Zubieta's** scholarship from the BC Lupus Society was extended for an additional year.

PAPERS AT SCIENTIFIC MEETINGS

Annual European Congress of Rheumatology (EULAR 2014), June 11–14 2014, Paris, France

1. **Barnabe C,** Huang W-T, Sun Y, Boire G, Hitchon CA, Keystone EC, Thorne JC, Haraoui B, Curtis J, Tin D, Pope JE, Bykerk V, CATCH Investigators. Sociodemographic and health status characteristics explain clinical outcome trajectories in early inflammatory arthritis (EIA). Ann Rheum Dis 2014;73:Suppl 2:74.

Disease trajectories in early inflammatory arthritis are influenced by socio-demographic and health status factors including age, sex, comorbid disease, smoking status, ethnicity, income, and employment. Differing therapeutic requirements are reflected in these trajectories. To achieve further improvements in early inflammatory arthritis outcomes, population health strategies addressing social determinants of health and patient-tailored treatment strategies are needed.

2. **Barnabe C,** Marotte H, Scharmga A, Kraus S, Burghardt A, Hauge E-M, Boutroy S, Toepfer D, Engelke K, Kocijan R, de Jong J, Li X, Stok K, Finzel S, SPECTRA. Rheumatoid arthritis erosion detection and measurement in longitudinal datasets using High-Resolution peripheral Quantitative Computed Tomography (HR-pQCT): Reliability Exercise-2 (RELEX-2). Ann Rheum Dis 2014;73:Suppl 2:654-655.

Agreement for the presence or absence of x-ray damage was 92.9%). Erosion (a measure of x-ray damage) dimensions did not significantly change over 1 year but a trend to reduction in mean size was observed. The case definition for erosions imaged by is valid in longitudinal studies. Despite variability in measurements, a trend towards changes in erosion size was demonstrated.

3. **Barnabe C,** Montpellier O, Manske SL, Boyd SK. Determining optimal hand position for reliable metacarpophalangeal joint width measurements using volumetric methodology by HR-pQCT. Ann Rheum Dis 2014;73:Suppl 2:1116.

Our 3D volumetric measurement method of joint space width for x-rays acquired with HR-pQCT technology is best up to 10 degrees of flexion, and care should be given to remaining in this parameter for longitudinal or repeated measures studies.

Case definition for erosions imaged with High-Resolution Peripheral Quantitative Computed Tomography (HR-pQCT): An international SPECTRA Reliability Exercise-1 (RELEX-1). Ann Rheum Dis 2014;73:Suppl 2:473-474.

We have devised a new case definition for x-ray damage with HR-pQCT imaging. Inter-reader reliability for detection is good, yielding promise to use HR-pQCT as an outcome measurement tool for bony damage.

5. **Cibere J, Kopec JA**, Wong H, Singer J, **Esdaile JM**, Nicolaou S, Guermazi A. Knee effusion is a risk factor for prevalence and progression of bone marrow lesions: A population-based study. Ann Rheum Dis 2014;73:Suppl 2:259.

In this 3-year study of painful early knee osteoarthritis, people with swelling of the knee on examination had a 5-fold increased risk of bone bruising on MRI and had a 3-fold increased risk of worsening of bone bruising over 3 years. Since bone bruises have been linked to subsequent cartilage damage and progression of osteoarthritis, assessment for knee swelling may be a useful and inexpensive test for identifying people with bone bruises, and therefore at risk of osteoarthritis progression, in clinical trials.

 Creaser C, Harrison T, Martin L, Barnabe C. Body mass index and its relationship to disease activity in early rheumatoid arthritis. Ann Rheum Dis 2014;73:Suppl 2:1210-1211.

In our study no relationship existed between obesity and disease severity at initial assessment or response to therapy. The cardiovascular risk due to rheumatoid arthritis in these patients overwhelms the already recognized cardiovascular risks associated with obesity.

7. **De Vera M,** Galo J. What are the effects of interventions targeting medication adherence in rheumatic diseases: A systematic review. Ann Rheum Dis 2014;73:Suppl 2:459.

Medication adherence has been reported as low as 30% in rheumatoid arthritis, 49% in systemic lupus erythematosus, and 17% in gout. We reviewed studies of medication adherence, to understand how heath care providers can improve it. There was almost no information.

8. **Feehan L, Clayton C, Carruthers E, Li LC**. Feasibility of using Fitbit Flex to motivate people with rheumatoid arthritis to be physically active. Ann Rheum Dis 2014;73:Suppl 2:1204-1205.

This study examined the feasibility of using a small interactive physical activity monitor worn on the wrist (FitBit FlexTM) to monitor daily activities over 4-weeks in ten people living with rheumatoid arthritis. All participants enjoyed using the physical activity monitor; suggesting the FitBit FlexTM may be a promising motivational tool for promoting physical activity in people living with rheumatoid arthritis.

9. Harrison T, Martin L, **Barnabe C**. Should a successful early inflammatory arthritis clinic also address cardiac risk? Ann Rheum Dis 2014;73:Suppl 2:163-164.

Patients in our Early Inflammatory Arthritis clinic with a diagnosis of rheumatoid arthritis are well managed from the perspective of their joint pain and swelling. However nearly half had much higher scores for heart risks compared to the Canadian population. The Early Inflammatory Arthritis clinic may be an ideal setting to educate patients about cardiac risk.

10. **Harvard S**. Developing quality criteria from the assessments in Ankylosing Spondylitis Society (ASAS) and European League Against Rheumatism (EULAR) ankylosing spondylitis management recommendations: Towards quantitative definitions of non-compliance. Ann Rheum Dis 2014;73:Suppl 2:433.

We report the results of a three round Delphi study in which a set of quality indicators was developed from the Assessment of Spondyloarthritis Society/European League Against Rheumatism clinical guidelines for ankylosing spondylitis. These indicators will be useful in future studies aimed at evaluating the effects of guideline adherence.

11. Kopec JA, Heath A, Sayre EC, Cibere J, Li LC, Marra CA, Liu RR, Esdaile JM. Prevalence of joint pain and self-reported osteoarthritis in British Columbia, Canada. Ann Rheum Dis 2014;73:Suppl 2:257-258.

In a survey of 2,233 randomly selected adult residents of British Columbia, 21% reported osteoarthritis of any joint. Knee osteoarthritis was present in 10% of the population and hip osteoarthritis in 4%. Close to 10% reported osteoarthritis in multiple joints.

12. Li LC, Kopec JA, Wong H, Cibere J, Zhang C, Sayre EC, Ye J, Barber M, Prlic H, Esdaile J. Prevalence of femeroacetabular impingement in Caucasians compared to Chinese in Vancouver, Canada: A population-based study. Ann Rheum Dis 2014;73:Suppl 2:457-458.

Femeroacetabular impingement is an abnormality of the hip visible on x-ray. It is thought to lead to osteoarthritis of the hip. 201 Chinese aged between 20 and 49 were recruited in Metro Vancouver and femeroacetabular impingement was present in 44/134 women and 32/67 men. Our findings contribute new information on the prevalence of femeroacetabular impingement among Chinese living in North America.

Is early DMARD use associated with less joint replacement surgery? An analysis of 5,199 incident rheumatoid arthritis (RA) patients. Ann Rheum Dis 2014;73:Suppl 2:219-220.

This study using administrative health data from Quebec on people with new onset rheumatoid arthritis with medication coverage under the Quebec provincial drug plan, found that greater use of methotrexate in the first year after diagnosis was associated with a lower risk of joint replacement surgery later on, suggesting that early use of methotrexate may protect the joints and prevent the need for future joint replacement.

14. Yurkovich M, Sayre EC, Shojania K, Aviña-Zubieta A. The risk of myocardial infarction and cerebrovascular accident in patients with Sjögrens syndrome: A general population-based cohort study. Ann Rheum Dis 2014;73:Suppl 2:142-143.

We tested whether having an inflammatory disease such as lupus would increase the risk of having another inflammatory disease such as COPD (chronic inflammation of the lung) compared to people of the same age and gender from the general population. Our results showed that lupus patients have 2 times more risk of developing COPD than people without lupus. Moreover, the risk was 6 times more within the first year after lupus onset. These results confirm the role of inflammation in the development of COPD.

15. **Yurkovich M**, Sadatsafavi M, **Sayre EC, Esdaile J, Aviña-Zubieta A**. Elevated risk of chronic obstructive pulmonary disease in systemic lupus erythematosus: A population-based study. Ann Rheum Dis 2014;73:Suppl 2:180.

This is the first large study assessing the risk of heart attacks and strokes in people living with Sjögrens disease (a disease that is related to lupus, but mainly characterized by dry eyes, dry mouth and non-destructive arthritis). We found that patients with this disease have a two times greater risk of heart attacks (240% more risk) and 60% greater risk of strokes than people without Sjögrens.

Canadian Physiotherapy Association Congress, June 19-22, 2014, Edmonton, Alberta

 Westby MD, Carr S, Kennedy D, Brander V, Bell M, & Backman CL. Post-acute physiotherapy for primary total hip arthroplasty: A Cochrane systematic review. CPANC: http://myorthoevidence.com/ace/6682/. We assessed whether people who had undergone a total hip or total knee replacement within the previous six months could make further improvements in their day-to-day activities, quality of life and physical activity levels by participating in a 6-week land and pool-based exercise program. People who completed the exercise program had clinically important improvements in their walking and stair climbing speed and quality of life and that 50% improved their overall physical activity level. We concluded that a community-based exercise program is safe and may enhance further physical recovery after hip and knee replacement.
