ANNUAL REPORT OF THE SCIENTIFIC DIRECTOR

TRAINEES

New Trainees

Nicole Andersen (Supervisor: **Deborah Da Costa**) is a new PhD student in Counselling Psychology at McGill University who will be evaluating a new online program that will help people with inflammatory rheumatic diseases deal with sleep problems.

Faye Cooles (Supervisor: **John Esdaile**) is a rheumatologist from the UK doing a postdoctoral fellowship at UBC. Her project, entitled “*Effect of Immunosuppression following solid organ transplant in autoimmune rheumatic diseases*”, will review the collective experience of people with autoimmune rheumatic diseases who received an organ transplant at UBC to see how the medications to prevent rejection affected the control of their disease.

Dani Contreras (Supervisor: **Cheryl Barnabe**) is a new Master’s student in Community Health Sciences at the University of Calgary, with a specialization in Health Services Research. Her thesis research will assess the use of emergency department services by people with inflammatory arthritis.

Narsis Daftarian (Supervisor: **Antonio Aviña-Zubieta**) is an ophthalmologist and retina specialist trained at the University of Tehran pursuing Doctoral studies in Experimental Medicine at UBC. Her thesis project “*Retinal Toxicity And HydroxyChloroquine Therapy (INTACT) - A Prospective Population-based Cohort Study*” will determine accurately how often this very rare side-effect that can affect vision occurs with the use of hydroxychloroquine, a very beneficial medication commonly used for lupus and rheumatoid arthritis.

Mohammed Mujaab Kamso (Supervisor: **Glen Hazlewood**, Co-supervisor Dr Rob Deardon) is a new PhD student in Community Health Sciences at the University of Calgary. His research project, entitled “*An automated process for Bayesian living network meta-analysis and evaluation of the certainty of evidence using the GRADE framework: an application to rheumatoid arthritis treatment recommendation*” will lay the foundational work for guidelines to get updated on an ongoing basis as new evidence emerges, making them “live guidelines”.

Juliana Mollins (Supervisor: **Linda Li**) is a physiotherapist pursuing PhD studies in Rehabilitation Sciences at UBC. Her research interests combine her experience in both academic and clinical practice to address the needs of the ageing population, particularly as it relates to their mobility, activity, and musculoskeletal health.

Kasra Moolooghy (Supervisor: **Diane Lacaille**) is a medical doctor trained in Iran pursuing a Master's in Experimental Medicine. Kasra will be comparing *"the risk of adverse events, such as infections, malignancies, and mortality, associated with different classes of biologic agents used in the treatment of rheumatoid arthritis"*.

Maureen O'Brien (Supervisor: **Cheryl Barnabe**, Co-supervisor Dr. Ranita Manocha) is a student at the Cummings School of Medicine doing a Masters in Joint Injury and Arthritis Research. Her thesis research will evaluate an app ICanWALK© that helps Canadians learn how to use walking aids properly (<https://icanwalk.info>).

Daniel Onwuka (Supervisor: **Mollie Carruthers**) is an undergraduate co-op student working on a rare disease that can cause widespread inflammation in many organs. His research project entitled *"Mass Spectrometry Analysis in IgG4-related disease"* aims to help diagnosing this disease earlier.

Sharan Rai will begin a postdoctoral fellowship at the Harvard T.H. Chan School of Public Health with Co-Supervisors Dr. Qi Sun, Dr. Kyu Ha Lee, and Dr. **Hyon Choi**. Her research will *"leverage metabolomics and microbiome data to further our understanding of how diet is related to risk of gout"*. She has received a three-year Canadian Institutes of Health Research fellowship to complete her training.

Fatima Shah (Supervisor: **Cheryl Barnabe**) is a new Master's student in Community Health Sciences, Health Services Research specialization, at the University of Calgary. Fatima's research aims to understand the root causes of hospitalizations that could be avoided in patients with inflammatory arthritis, and will investigate not only the biomedical factors but also the socioeconomic factors that contribute to hospitalizations.

Jocelyn Thomas (Supervisor: **Glen Hazlewood**) is a new Master's student in the Cummings School of Medicine at the University of Calgary. Her research project is entitled *"Moving towards the personalization of treatment choices in rheumatoid arthritis"*.

John Yan (Supervisor: **Jackie Whittaker**) is a new Master's student in Rehabilitation Sciences at UBC. John will be investigating *"the neurophysiology of the quadriceps muscles in young persons at increased risk of osteoarthritis after a sports injury"*.

Kai Zhao (Supervisor: **Hui Xie**) successfully completed his MSc at Simon Fraser University and commenced his PhD in September continuing under the supervision of Dr. Xie. For his PhD Kai will be developing novel statistical methods to analyse population-based administrative data to improve health outcomes for arthritis patients.

Trainees who completed their degrees

Jesse Charlton (Supervisor: **Michael Hunt**; Co-Supervisors: **Linda Li**, and Janice Eng) successfully defended his PhD thesis on June 9th. His topic was “*Technology-enabled gait monitoring and modification in real-world settings for the management of knee osteoarthritis*”.

Sarah Cooper (Supervisor: **Deborah Marshall**) successfully defended her MSc thesis on July 28th. Her topic was “*Evaluating key performance indicators in juvenile idiopathic arthritis to improve quality of care*”.

Luiza Grazziotin (Supervisor: **Deborah Marshall**) successfully defended her PhD thesis on January 11, 2022. Her topic was “*Overcoming methodologic challenges in economic assessments of personalized treatment in children with juvenile idiopathic arthritis*”.

Alexandra Legge (Supervisor: **Diane Lacaille**) completed a Postdoctoral Fellowship in July. Her research project was “*Using administrative data to construct and validate a frailty index as a measure of susceptibility to adverse outcomes among patients with rheumatoid arthritis*.”

Elena's thesis examined the impacts of a nurse-led clinic model for stable patients with RA. She has already started post-doctoral training with Dr. Marshall on a project entitled “*Developing a sustainable and evidence-based integrated model of care for chronic pain management in Alberta*.”

Laurence Mainville (Supervisor: **Paul Fortin**) successfully obtained her Master's in October 2021. Her thesis research was a “*Retrospective cohort study comparing disease severity in psoriasis treated with biotherapy under a public or private drug insurance plan*”.

Alix St Aubin (Supervisor: **Paul Fortin**) successfully completed her Masters of Clinical and Biomedical Sciences at the Université Laval. Her thesis research tested a 12-week home-based exercise program specifically designed for people with rheumatoid arthritis compared to exercise performed under supervision at a physiotherapy clinic.

Trainee Salary Awards

Narsis Daftarian (Supervisor: **Antonio Aviña-Zubieta**) has been awarded the prestigious Andrew Nord Fellowship in Rheumatology from the University of British Columbia. This is a four-year \$88,000 award. The award is funded by the Estate of Andrew Nord with the goal to fund arthritis research that will "prevent the disease from its devastating onslaught, find better ways to live with the disease, and to find the cause, leading to a cure".

Rashed Hoque and **Kai Zhao** (Supervisor: **Hui Xie**) both received Arthritis Research Canada/Lilly Rheumatology Research Trainee Scholarships for giving an oral presentation of their research at the annual EULAR Congress in Copenhagen.
