### **TRAINEES**

### **New Trainees**

**Deniz Bayraktar** (Supervisor: **Linda Li**) started a one-year postdoctoral fellowship at Arthritis Research Canada Vancouver in July 2023. He is working on Dr. Li's project "Implementing an evidence-based exercise program to reduce falls in community-dwelling older adults".

# **Arthritis Research Canada Trainees Day and Scientific Retreat**

Arthritis Research Canada Scientists and Trainees gathered on October 13-14, 2022 for the first time since 2019 for an in-person Scientific Retreat. In total 18 Researchers and 22 trainees attended the Retreat from Laval, Edmonton, Calgary and Vancouver. The Retreat was preceded by our inaugural Trainee's Day on October 12<sup>th</sup>. 31 Trainees attended the Trainee's day which included presentations by the Arthritis Patient Advisory Board and workshops on "Planning next steps in your career" (Roberta Borgen) and "Shaping and sharing messages from your research" (Alison Hoens).

#### **Arthritis Research Canada Trainee Network**

The Trainee Network was launched in 2023, led by **Dr Mary De Vera**, Associate Director of training. Town hall meetings were held with trainees to understand their needs. A trainee steering committee has been struck. A Trainee day with workshops and networking opportunities was organized in conjunction with the Arthritis Research Canada Retreat.

Several one on one mentoring sessions for Trainees with our Emeritus Scientific Director, **John Esdaile** were held over the year (in person over lunch and virtually).

On March 6, 2023 **Alison Hoens** presented a session on "Shaping & Sharing Messages From Your Research – PART 2, Tips for Arthritis Research Canada Trainees". This webinar built on the prior session held at the Retreat and provided trainees with opportunities to learn about strategies and resources for them to shape and share messages about their research; and practice delivering their messages and receive feedback from peers.

The inaugural A.J.E. Child Chair in Rheumatology Outcomes Research Monthly Trainee Seminar Series was launched in January 2023, co-hosted by Arthritis Research Canada Centres in Calgary (**Cheryl Barnabe**) and Vancouver (**Mary De Vera**). The seminars are held monthly. Trainees from across the country attended the seminars in person and online.

MITACS Trainee Funding. Meetings were held with MITACS representatives (Dr. Annika Rosanowski, PhD and Dr. Andrea Globa, PhD and Senior Advisor) and **Mary De Vera** to discuss MITACS programs and potential partnerships with Arthritis Research Canada/Arthrite-recherche Canada. As a result of the meeting the MITACS advisors have been invited to present to the Faculty at the October Research webinar so Pls and trainees can learn about their programs. In addition we are conducting a pilot process for applying for MITACS funding with two Trainees applying for funding which will be turned into a resource for future applications.

Three Arthritis Research Canada Trainees Vienna Cheng, (Supervisor: Mary De Vera) Rashed Hoque (Supervisor: Hui Xie) and Justin Losciale (Supervisor: Jackie Whittaker) had the opportunity to attend the Arthritis Community Learning Circle on <u>Truth and Reconciliation</u> hosted by Arthritis Consumer Expert on June 20 – 22, 2023.

Nine Trainees presented at the Annual Arthritis Patient Advisory Board Trainee's night on May 23, 2023.
